
- Opening remarks presented by President Hollingsworth

- Treasurer's report presented by Kris Bridges. Mr. bridges discussed the BB&T account and the break down to include an overview view, room fees, dues, working balance, teller fee, global council money, merchant account, and the credit card.
- Motion made by Eby and second by Strasabaugh unanimous vote for acceptance
